DIRECTORS MEETING: January 23, 2022

The meeting was called to order by the president at 11:50

motion to approve the agenda. second. All voted in favor. Motion carried.

OLD BUSINESS

Rope Event at Ponoka: this was discussed at the AGM. See the minutes for 2022 AGM for information.

Directors at Ponoka: we need all directors who are at our Ponoka event to step up and contribute to the workload.

NEW BUSINESS

Elections :

President – nominates Laurie Bresee. Laurie Bresee accepted the nomination. No other nominations. Laurie Bresee is president.

Vice President : nominates Janet Patriquin. Janet Patriquin accepted the nomination. No other nominations. Janet Patriquin is vice president.

Secretary/Treasurer: nominates Lorene Stone. Lorene Stone accepted the nomination. No other nominations. Lorene Stone in secretary/treasurer.

Administration Costs: been looking into our costs of operating annually. Our costs are barely being covered and she has come up with some ideas to help increase our annual revenue.

- 1) motion that we increase the CBHI per run fee from \$10/run to \$15/run. seconded. All voted in favor. 0 opposed. Motion carried.
- 2) Increase the blanket sponsorship from \$150 to \$200 per blanket.
- 3) Increase the cost of stalls and power at our event by \$5 per night
- 4) Increase the open entry fee at our event from \$65 to \$70 per run. The administration fees will increase from \$25 to \$30 per run.
- 5) Increase the youth entry fee at our event from \$35 to \$40 per run. Administration fees on youth entries will not be increased.
- 6) The 2D side pot in the futurity and derby will remain the same the same and we will not take an administration fee from it.
- 7) Add a senior side pot in the open and pay it out as an average and not per run. Senior age is 50 years. The entry fee will be \$50 and all entry money will be paid out.

motion to approve all of the above changes on #2-7. seconded. All voted in favor. 0 opposed. Motion carried.

Paying in a stallion by previous owner to be eligible to receive super stakes money and outstanding certificates: currently we are paying super stakes money to stallion owners who have not continued to pay their stallion into the super stakes program and it is felt that this should change. motion that any stallions not paid into the CBHI by June 1, 2022 that were previously super stakes stallions will be subject to a \$50 processing fee per transaction. seconded. All voted in favor. 0 opposed. Motion passed.

Super Stakes Money Investment: our second last investment was taken out for the 2021 super stakes payout and we have the interest money generated from that investment that needs to be reinvested. motion that we move this interest money into a short-term investment with Servus Credit Union. seconded. All voted in favor. 0 opposed. Motion carried.
